## TD SYNNEX Coaches™ TERMS OF USE

The TD SYNNEX Coaches Terms of Use (the "Terms of Use") between You (either an individual or the authorized representative of a company or other entity) and TD SYNNEX ("TD SYNNEX") regarding the TD SYNNEX Coaches Web Portal (the "Service") and related content of TD SYNNEX and its licensors (the "TD SYNNEX Content"), available through this site (the "Site"). The Site, Service and the TD SYNNEX Content are collectively referred to as "TD SYNNEX Coaches" for purposes of these Terms of Use. If You are agreeing on behalf of a company or other entity to be bound by the terms and conditions of these Terms of Use, You are representing and warranting that You have the authority to act on behalf of, and otherwise bind, the company or other entity. In all such cases, each reference to "You" or "Your" in these Terms of Use shall refer to You or to the company or other entity You represent, as applicable. Persons under the age of 18 are prohibited from using TD SYNNEX Coaches. By Your use of TD SYNNEX Coaches, You represent that You are at least 18 years old. TD SYNNEX reserves the right in its sole discretion to change the Terms of Use at any time.

## TERMS AND CONDITIONS FOR USE

**TD SYNNEX Coaches Users.** Users of the Website, the Content, and the Services consist primarily of "Coaches" and "Partners". Partners and Coaches will register for use of the Website in order to find information advice, and guidance relating to hardware, software, services, and IT solutions. If Partners fail to attend more than two meetings without 24-hour notice, the Partner account may be suspended. coaches in excess (more than 3) and not showing up to meetings may result in account suspension or termination.

**License.** Conditioned upon Your acceptance of all of the terms and conditions in these Terms of Use, and otherwise provided to You, You are granted a limited, nonexclusive, nontransferable, non-assignable license to use TD SYNNEX Coaches via the Site for Your internal business purposes only. You may not provide the Service or TD SYNNEX Content to any third party or otherwise make use of the TD SYNNEX Coaches outside the limited scope of this license.

Password and Security. A User or customer account is required to access certain portions of TD SYNNEX Coaches and may be accessed and used only by those authorized individuals who are registered with TD SYNNEX to open a User account, You must complete the registration process by providing TD SYNNEX with current, complete, and accurate information as prompted by the applicable registration form.
